## • GENERAL REQUIREMENTS •

- Meet all Rio Grande admission requirements by deadline.
- Submit application with all applicable documents to Dr. Tracey Boggs, Program Director, by April 1, 2021, to be considered for admission. Incomplete applications will not be considered for admission into the program.
- All Allied Health programs are subject to random drug/alcohol testing, and BCI and FBI background checks. Students are responsible for all testing fees. For more information on policies, see catalog.

## • ACADEMIC REQUIREMENTS •

- High school or college cumulative grade point average (GPA) of 2.5 or higher. High school and College Credit Plus seniors may apply without attending a year of college first. All applicants must have graduated from high school before admission into the program. All other College Credit Plus students are ineligible.
- Students with GEDs must successfully complete 24 credit hours as a full-time student or successfully completed 24 credit hours in consecutive semesters (excluding summers) of general courses required in RAD program.
- The college cumulative GPA will be used in place of the high school cumulative GPA for all students who have attended college for a minimum of 12 credit hours.
- ACT composite score of 20 or higher.
- Completed one unit each of high school biology I, algebra I, chemistry I, and physics I/physical science, or college-level equivalents. The last completed unit score or final score in those subjects must be a minimum grade of "C".
- Successful completion of AHC 10101 – Introduction to Allied Health Professions. This is waived for entering high school seniors, College Credit Plus seniors, and transfer students accepted into the program. All current Rio students must have completed or be currently enrolled in the course, and earn a minimum grade of "C".
- Developmental courses (if needed) in English, writing, and math must be completed before admission into the program.
- The student must earn a minimum of a "C" in Principles of Human Anatomy & Physiology I, Pharmacology and The Human Body, Sectional Anatomy, and/or Standards for Patient Care if enrolled in these courses.
- Any required and/or prerequisite courses in progress have to be completed with a minimum grade of a "C" by the end of spring semester to be eligible.
